**MONTHLY PERFORMANCE COMMENTARY**

Third Point Investors Limited returned -1.2% on a NAV basis in December 2024, compared with a -2.6% return for the MSCI World Index and a -2.4% return for the S&P 500 Index. During the month the Company's share price returned 2.4%, reflecting a narrowing in the discount to NAV from 24.2% to 21.4%. The top contributors for the month included e-commerce company Amazon.com Inc., semiconductor manufacturing company TSMC, and automotive and clean energy company Tesla Inc. The top detractors for the month included industrials and materials company Ferguson Enterprises Inc., utility company Pacific Gas and Electric Co., and industrials and materials company CRH PLC.

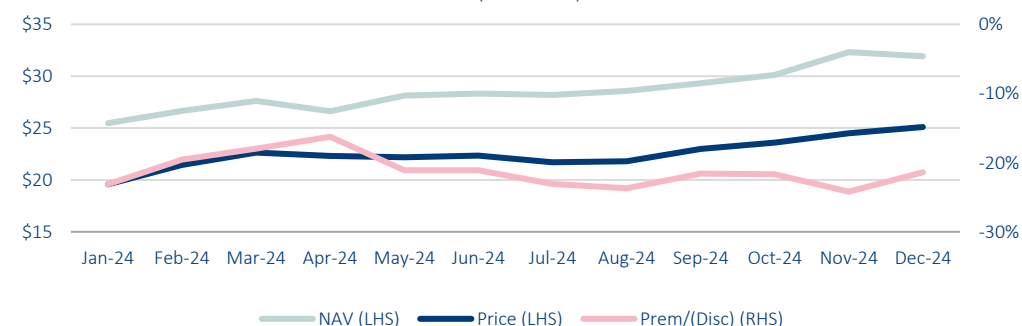

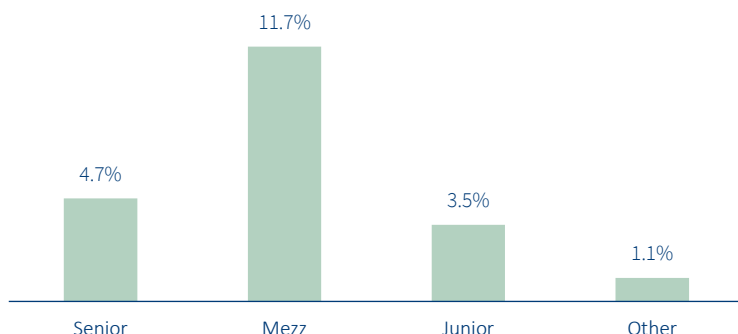

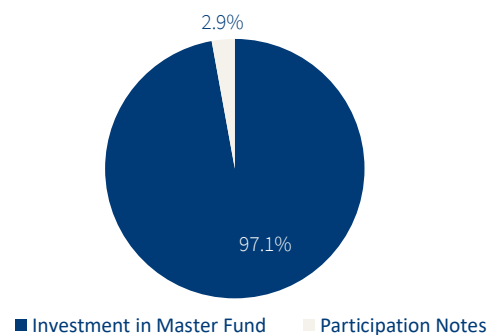
